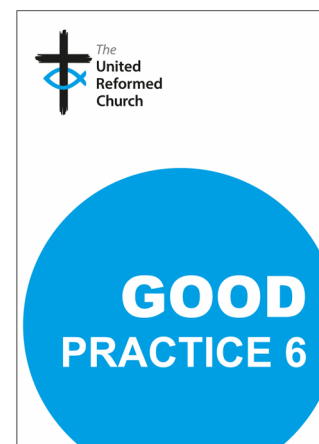

Summer has finally arrived and what have we been up to in safeguarding.....our Training and Development Coordinator has developed a new course around safeguarding children, the Church House safeguarding team welcomes a new member staff and the entire safeguarding team comprising also Synod Safeguarding Officers met together for an annual safeguarding residential.

### Good Practice 6 (GP6) Resources

Recent additions include an update to the safeguarding clauses in Letting Agreements for groups or organisations who use URC facilities (Resource SA6), and guidance on handling, retention and disposal of DBS certificates (Resource P6). There has also been a small update to page 1 of the local church safeguarding policy template (Resource P1) in the section 'who the policy applies to' which reflects the updated Lettings Agreement. ### Disclosure and Barring Service

**DBS Update Service** - we are currently drafting guidance on using the DBS Update Service for churches that may want to do this. The guidance should be available in the autumn.

**A Note on Basic DBS Checks** - a number of DBS roles instigated by churches and synods require a basic check. These are currently:

- Church Administrator
- Church Caretaker or Cleaner
- Church Treasurer
- Synod Treasurer
- Synod Trustee

These checks do incur a charge of £18 which needs to be paid for by the applicant in order to complete the application. Be assured that this is not a charge from Due Diligence Checking (DDC) but rather the Disclosure and Barring Service. Please do ask the applicant to pay the fee and, where appropriate, claim back from the church or Synod.

## Training Update

**Training Review Group** - the group met in June to discuss all aspects of safeguarding training, from participation and publicity, to monitoring training attendance and course content. This is ever evolving within the safeguarding training framework. At each meeting of Training Review Group we welcome a member of a local church to join us. 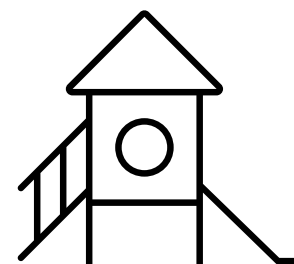

### Suicide Awareness Training

Should churches wish to explore the topic of suicide awareness, we would refer you to the [Zero Suicide Alliance](#) (ZSA) which is a national organisation that aims to empower, educate and equip individuals and organisations to support suicide awareness and prevention. ## Speaking to Children about Safeguarding

Talking to children about safeguarding is just as important as talking to adults. We need to ensure that in churches we empower children to recognise harmful situations so they can reach out to an adult. Children need to know that they can, and should, speak up when they feel worried, frightened, or unsure about something, know who they can speak to, and that they will be listened to and believed. These are important lessons for children to learn, and all settings should have these as part of raise awareness around safeguarding.



The recommendations from the IICSA report conclude that “empowering children and young people to talk about [abuse] and opening up discussions between them and a broad range of adults, is essential,” but as an adult, knowing how to do this confidently with children can feel daunting. Where do you start? What do you include? How do you ensure you use language that children will understand?

The independent safeguarding charity *Thirty One Eight* have created the character of Roarry the Lion, a friendly and trusted guide, helping children to navigate the dangers and learn important skills such as how to raise their voice, their “roar” and speak up when things aren’t right. The lion is a familiar image to Christians, associated with wisdom and of God himself and personified by characters such as Aslan from C.S. Lewis’ Narnia books.

Drawing on stories from the Bible where children have spoken up or spoken out about issues and injustice, the resources support children to learn that the Bible shows us that God wants us to use the voice he has given us to speak up for ourselves and others.

Roarry’s Rangers know how to keep safe by following the Ranger Code. The code gives children four key points to remember and take away. These are:

- ❖ When I feel worried or upset, I won’t keep it to myself.
- ❖ I will raise my roar and speak to someone I trust.
- ❖ I know which grown-ups I can go to for help.
- ❖ I will use my roar to speak up for others.

The URC's Safeguarding Committee are committed to ensuring that throughout the Church we work in line with our safeguarding policies, procedures, and legislation and as a result have endorsed a piece of work to look at internal and external auditing need.

The aim of the group is to take a proposal back to the Safeguarding Committee/General Assembly with a plan of the audit process the denomination should adopt.
